### Treatment Access Workgroup Highlights (Apr 12)



1. Updates and Announcements

3. Epic HCV registry update: The hep C registry is now built out in EPIC for SF Health Network and providers are able to run reports on their own through My Reports section.

## Coordinating Committee Meeting Highlights (Apr 28)



Much of the meeting was spent on strategic planning with facilitators at In The Works.

1. Introductions: Shared a little about our roles for the benefit of our guests from In the Works.
2. General Updates
3. Budget Update: SF-CAN funding request is due. Discussed things we could ask for.
  - a. Incentives to place some Community Navigator in orgs where there's a need for help and that would be able provide training and support.
  - b. Evaluation planning.
  - c. Jail Health Services
4. Perinatal Hep C Report Update - brief overview
5. Applications for revitalization grants are due May 4th. Discussed how to handle reviewing. Backbone will review and make recommendations to the Coordinating Committee, unless we get so many applications that it makes sense to request participation from outside reviewers (TBD).
6. Strategic Planning 2023-2026 with In The Works: Keep it simple with 3-5 overarching goals;
  - a. Support co-leads to reflect on structure and how the work is getting done;
  - b. Create draft overarching turn-the-curve goals for feedback/discussion;
  - c. Create sub-group goals to be in direct service to EHCSF goals and focus on problem solving;
  - d. Equity;Review these goals together over the course of the year.
