1. Budget Update
2. Community Meeting recap - we saw a lot of new faces but low attendance among CBO members. Many attendees were from the adjacent alley and the 6th street neighborhood in large part due to outreach by a few community navigators.
3. International Network on Health and Hepatitis in Substance Users (INHSU) symposium announcement and discussion
 - a. The INHSU, in addition to hosting international conferences, also hosts intervention one day training sessions. They are bringing this to the US for the first time this year. They chose San Francisco for the West Coast region and have asked EHCSF to help plan and support attendance.
 - b. They try to bring in a large cross-section of attendees and are hoping for about 40-60 attendees and will tailor the program to San Francisco's needs.
 - c. This will be either the 2nd or 3rd of November.
