Coordinating Committee Meeting Highlights (May 6)

Community Research & Data Stewardship Workgroup Highlights (May 20)



1. Presentation on the Basics of HCV data by Dr. Meghan Morris highlighting the major methods used to calculate prevalence and incidence, and progress towards elimination in San Francisco.
2. Overview of Results-Based Accountability (RBA). RBA is the framework that End Hep C SF uses for its evaluation of HCV elimination progress. Shelley Facente described the RBA model and how EHCSF uses data to guide HCV elimination work.
3. Discussion of End Hep C SF's data dashboard. Shelley explained and demoed the dashboard and led a group discussion on how the dashboard could be enhanced.
